MINUTES

Roll Call: Robert Haugh, David Molter, Allan Kasprzak and Gus Moulas. On phone: Steve Nelson.

Also present, Police Chief James Gage, Village Manager, Mr. De Angelis and Assistant Chief Hennen.

1. **Call the Meeting to Order.** The meeting was called to order by President Robert Haugh at 7:30 A.M..
2. **Review and approve Minutes from August 26th, 2020.** Mr. Moulas moved and Mr. Kasprzak seconded the motion to approve the minutes. Motion passed unanimously to approve the minutes as amended.
3. **Police ‘Chiefs update on Departmental Personnel.**

Chief discussed succession planning and upcoming military leave regarding staffing and the possible promotion of someone to detective. He indicated that he has approached the village manager regarding possibly hiring an additional officer prior to future retirements and military leave.

4. **Interview of police officer candidates.**

This is further conditioned on being completed by March 31st, 2021. President Haugh seconded. Motion carried unanimously.
