

Dear Ms. Kendler:

We have been following the Reinders / Wangard Development proposals since February, 2016 and acknowledge some minimal listening by the developers to the resident's concerns has occurred.

We are opposed to the current development and will be speaking directly to the Village Board at its next public meeting (November 28th) as this is the only time we seem to have a forum for questions to our civic leaders.

Specifically our major concerns are:

1. Physical size and overall density of the Development. 250 foot 4 story buildings reaching nearly 60 feet in height in the heart of the Village is not consistent with the values of Elm Grove.
2. Use of Village Tax Bonding (TIF) Authority. When will the overall commitment of the Village be presented to the residents.
3. The site has contamination and the project seems to be structured to bury (Cover this up) with a large concrete parking structure. Will this adequately protect the Village and wells of residents?
4. Traffic in the Village from the 170 plus apartment units. Attempted monitoring failed.
