A RESOLUTION AMENDING THE 2022 BUDGET TO RECORD
REVENUES AND EXPENDITURES, LIBRARY GIFT FUND, ARPA FUND, DONATION FUND, AND INTER-FUND
TRANSFERS

WHEREAS, the Village budget is approved in November of the prior year, and the Village's practice is to amend the budget if needed to reflect actual activity within the specific funds for the calendar year, officially recognizing the financial transactions of the budget year, and

WHEREAS, the general fund concluded the year under budget and the Village is electing to transfer \$100,000 to the capital fund for future projects and \$100,000 to the Emergency Medical Services fund to provide continued support to the on call pay after the 2023 year supported by a special grant, and

WHEREAS, the sewer fund expenditures included sewer work on Watertown Plank Road which was determined during the paving project; and

WHEREAS, the stormwater fund expended \$444,500 to purchase the One Hour Martinizing property for the Underwood Creek Daylighting project; and

WHEREAS, the capital fund expenditure budget should be amended to reflect the costs for approved projects; the network computer system refresh, updates to the poolhouse, the purchase of the public works loader and sale of current loader and the North Avenue sidewalk project; and

WHEREAS, the Village received funds from the State of Wisconsin through the Federal Government American Rescue Plan Act of 2021 (ARPA) and authorized the use of these funds for a number of specific projects; and

WHEREAS, the Village library has a library gift fund which is supported through donations and overseen by the library board and is not budgeted for during the budget cycle; and

WHEREAS, the library gift fund received donations of \$41,343 and had authorized expenditures of \$48,210 for 2022 and this amendment will reflect this activity; and

WHEREAS, the Village also has a special revenue fund created in 2017 to manage donations received for future projects, and funds were received in 2022 for recreation activities, by the public safety departments for equipment and training, and support for the downtown flower baskets; and

WHEREAS, the debt service fund, includes an additional cost of \$401.00 on 2019 refunded debt above the 2022 budget; and

NOW THEREFORE BE IT RESOLVED that the Board of Trustees of the Village of Elm Grove amends the 2022 general and donation fund budgets to reflect the transfer of funds, and records the capital, debt, library gift, ARPA funds and donation fund activity as identified below.
